

TERMS OF USE

GENERAL

Welcome to the www.fashioninfluencerslab.com of the Fossil Group, Inc. dba Fashion Influencers Lab (the "Lab" or "We"). The following terms and conditions, together with any documents they expressly incorporate by reference, including without limitation the Privacy Policy (collectively, the "Terms of Use"), govern your access to and use of www.thefashioninfluencerslab.com, including any content, functionality, and services offered on or through this website (the "Site").
